M5+ (50+ years old) -73, -81, -90, -100 and +100kg

**Women:** (30+ years old) -63 ja +63kg

### 6. Competition rules

6.1. Competition is being held according to IJF rules (except repechage, which will be held from semifinals).

6.2. If there are less than 3 athletes in a weight category the category will be combined. The decision will be made by Estonian Judo association and organizer on spot.

6.3. Only athletes who haven't participated in any EJU and IJF tournament (except Veteran competitions) in last 2 years can participate.

6.4. Competition time is 3 minutes and Golden Score 1 minute.
